I've known the last three owners of this farm stretching over 20 years, and this farm has consistently had good whitetails on it. As I pulled up to the farm last week there where 3 nice velvet bucks standing in the beans eating mid day. In addition to whitetail deer I have also seen turkeys, and hunted turkeys on this property.

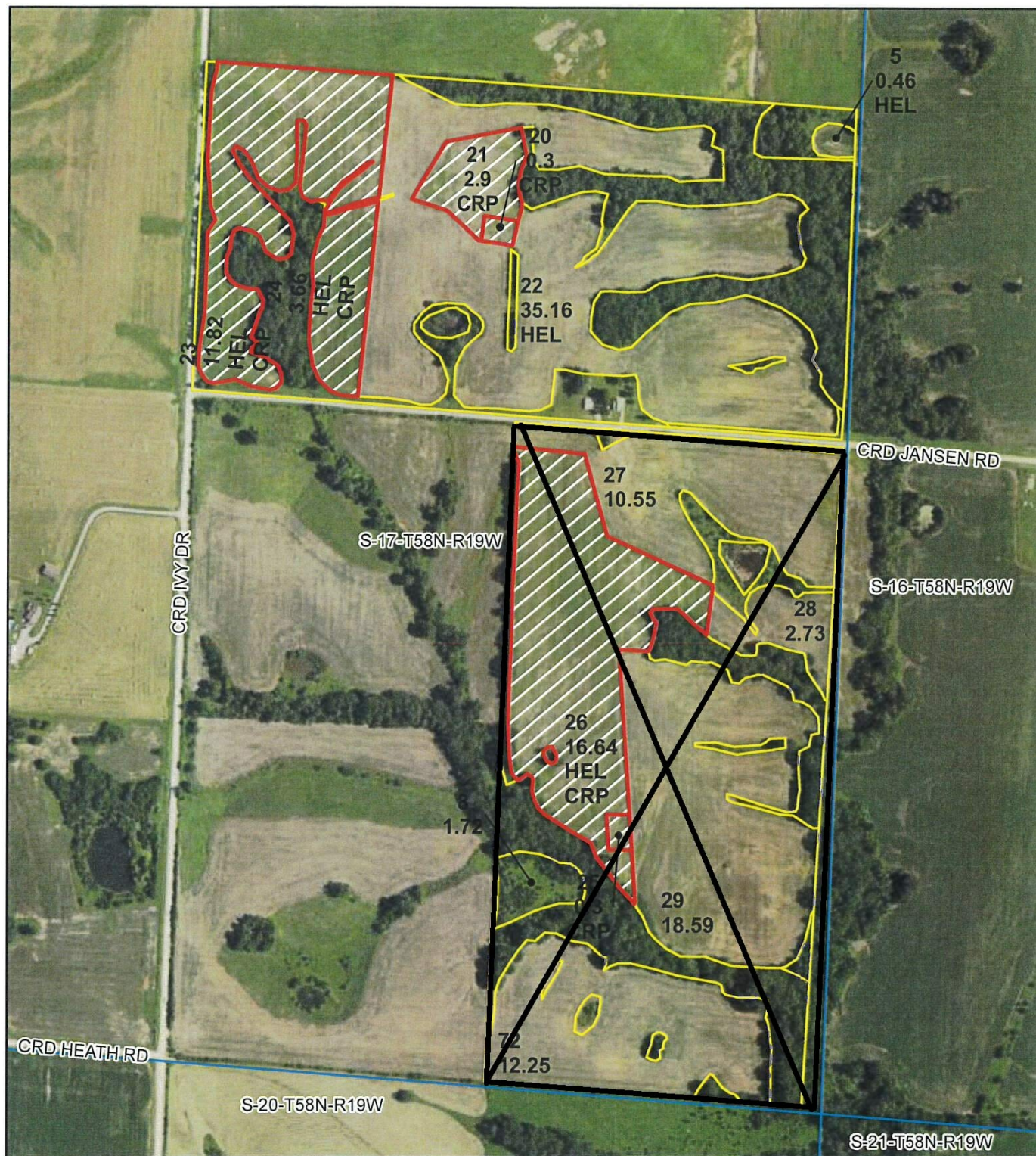
The farm currently has 35.62 acres in tillable production at a rental rate of \$170/acre or \$6055.40 annually.

The current owner in an effort to create more habitat has signed up an additional 15.02 acres into the CRP program. The CRP contract runs from Oct 1, 2020- Sept 30, 2030 with a payment of \$108.64/Acre or \$1631.77 annually.

A rental home on the property burned a couple years ago and would offer a great place to build a new home or cabin. The older barn, work shop is still in place.

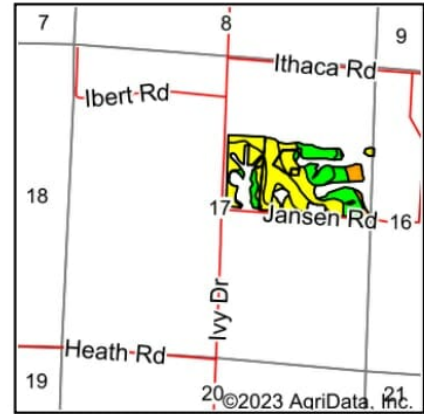
